


## WHY JOIN US?

## MANAGEMENT OF YOUR PERSONAL DATE

Polymeris is committed to ensure that the collection and processing of your data, carried out at the time of your membership, complies with the General Data Protection Regulation (RGPD) and the French Data Protection Act. The collection of personal data during your membership is essentially carried out to allow you to benefit from all Polymeris services:

- Directory,
- Member management (CRM database),
- Member communication (Weekly and monthly newsletters and emailing of events maximum 3 times per week),
- Information request to Polymeris teams,
- Contact with the Polymeris network,
- Access to the MyPolymeris platform.

This information will be processed by the administrative department and the communication department. We have complied with the RGPD legal framework by implementing the following elements:

- Information on the purpose of the application form: you know what the form is for and to whom we transfer the data.
- Minimization of data: we have reduced the amount of data requested depending on the case.
- Data security: Via SSL protocol and secure database management, we maintain a high level of security on the path of your data.

For visitors with privileged access to the MyPolymeris platform, you can set up your e-mail alert summarizing the latest content added to your member area. You can choose if you want to receive it or not and set its content.

#### Request for your personal data

As a reminder, here are all your rights under the RGPD. It is important to specify which right you wish to exercise to respond favourably.

## GENERAL CONDITIONS OF MEMBERSHIP

In accordance with current regulations, membership fees are subject to 20% VAT.

Membership renewal from one year to the next is tacit unless the member resigns (by registered letter with acknowledgement of receipt before 12/31 of the current year).

The membership fee following renewal remains unchanged, except where the following special conditions apply:

- Application of an inflation rate to all membership bands following a decision by the cluster's Bureau.
- Signature of a new membership form, at the request of the member or the cluster, agreement on a change of bracket.

#### Loyalty benefit:

When Polymeris was created, the cluster's Board decided to introduce a loyalty benefit in the form of a 3% discount after three consecutive years of full membership, increased by 1% after each additional year. To qualify for this discount, you must be up to date with your membership fees. Therefore, if you meet these criteria, you will benefit for this year 2025.

#### Renewal:

Membership renewable by tacit agreement, for a further renewable period of one year, subject to payment of the annual fee by the member.

When subscribing to PREMIUM membership, the member undertakes to comply with all the specific conditions set out below in the "PREMIUM Membership Conditions".

#### PREMIUM membership conditions/

Polymeris undertakes to exempt the member from the financial contributions usually applied to projects accredited by the cluster and funded during the current year.

PREMIUM members undertake to maintain their PREMIUM status for the duration of the funding of each approved project in progress.

Polymeris undertakes to co-develop and implement a specific action meeting the member's objectives in one of the cluster's strategic pillars, in agreement with the Polymeris team.

The member undertakes to subscribe to PREMIUM membership for a minimum of 2 years, ensuring continuity of services and added value.

Annual monitoring will be carried out to ensure that services are optimally adapted to the member's changing needs.
